I. Background:

<u>World Day of Social Justice</u> is an international day recognizing the need to promote social justice, which includes efforts to tackle issues such as <u>poverty</u>, exclusion, <u>gender equality</u>, unemployment, human rights and social protections.

On 26 November 2007, the General Assembly declared that, starting from the sixty-third session of the General Assembly, 20 **February** will be celebrated annually as the World Day of Social Justice. Then, The International Labor Organization unanimously adopted the ILO Declaration on Social Justice for a Fair Globalization on 10 June 2008.

Civil Society Organizations are also planning to celebrate the day in Nepal world day of social justice and aware the people and drawing the attention of Government and concerned stakeholders to address the burning issues of poor, marginalized and socially excluded people. Also, the celebration of world social justice day will strengthen CSOs to stand firmly for inclusion, equality, and dignity of excluded people.

As usual World social justice day in 2021 is also going to observe around the world this year with the **theme:** A Call for Social Justice in the Digital Economy. At this time, Covid-19, pandemic has created numerous issues regarding human rights, good governance, social justice, and others. The issues regarding with social justices are increased and people are striving for their all types of rights.

This year the civil societies working in human rights, social justice and good governance have planned to celebrate world social justice jointly.

2. Objectives of the day

As you know that Nepal Government has tried to address some issues of social justice through its constitution and different policies however there is remaining to formulate other specific and need also issue based policies and their effective implementation, need to implement integrated, sustainable life changing interventions for those target communities and people. Thus, some of the objectives are mentioned below:

- 1. To have common understanding among identified CSOs and strengthen our alliances to stand for Human rights, good governance, and social justice for all target communities.
- 2. To aware poor and marginalized people on significance of social justice also human rights.
- 3. To draw the attention of concerned stakeholders to address the issues of social justice.

3. Key Activities to observe world social Justice Day

The like-minded and committed civil society organization working in Human right, social justice and good governance and based on Kathmandu, held preparatory meeting in office of Freedom for all Nepal (FAN). Subsequently, we discussed and interacted on how to celebrate world social justice day in such Covid-19 pandemic. Actually, the team had concluded to celebrate effectively having collaboration with the concerned stakeholders. We made 3D (Demonstration, Dialogue and Delegation) and proposed the following programs:

- 1. Peaceful demonstration in Maitighar Mandala with placard Banner.
- 2. Dialogue will be held, followed by paper.
- 3. Delegation to office of Prime Minister and other concerned stakeholders.
- 4. Document the process and results very sensitively also disseminate among contributors and stakeholders.

4. Major Interventions and Achievements of celebration of World social justice 2021.

4.1. Demonstration at Maitighar Mandala, Kathmandu:

On 20th February 2021, the alliance of social justice and human rights organized a peaceful demonstration at Maitighar.

Numbers of the participants from diverse civil society organizations,

young people, marginalized communities have attended in the program, The demonstrator were



attended with different slogans hanging on the chest and banner. The demonstrators were slightly annoyed by police personnel because there are many other organizations and people are also raising their voice against dissolution of house of representatives by KP Sharma Oli. The case against house dissolution was in supreme court. The civil society organizations has jointly speak together for social



justice, human rights, good governance and marginalized people's rights. Subsequently, some of the representatives gave their speech on world social justice and its theme also role of young people and civil society.

The peaceful demonstration has participated the CSOs and their diverse wing. It has raised awareness and hold

accountable to stakeholders. The program was covered by more than 30 media. Online and other media has aggressively broadcasted the news and it has supported to raise the voce and aware people for social justice and role of young people to ensure human rights and social justice.

4.2. Dialogue progarmme

The civil society organizations committed in social justice and human rights organized the

dialogue program on the 21st of February 2021. The participants of the dialogue program were representatives of the civil society organizations and other citizens from different groups like people with disability, religious minority, Dalit and other poor people. The program was held on Nepal Tourism board, hall.

The program was moderated by Mr. Khagendra Oli, General Secretary of the Freedom for All Nepal (FAN) and vote of thanks was given by Mr. Sitaram Ghale Pariyar from Global Alliance Against Untouchability (GAAU). The dialogue was also followed by paper presentation led by Mr.









6. Recommendations and Future Actions

We all know that unity is the strength. We had prepared to celebrate world social justice day in 3D (Demonstration, Dialogue and Delegation) model. Among them, Due to different reasons including Covid-19 pandemic, this alliance could not be able to conduct delegation to government authorities compiling all the issues collectively. Therefore, few recommendations and future Actions are mentioned below:

- Celebration of day is most utmost important to aware community people, target beneficiaries and draw the attention of poor and marginalized communities, hence, strong preparation and common understanding among alliance members is must.
- Contextual and seasonal alliances only work for specific business but such alliance should be
 developed from longstanding discussions which supports us to contribute, collaborate and
 lead the sessions from heart.
- Ownership and volunteerism are the most significant aspect for sustainable results, so such alliances should be continued.
- Small is beautiful, so no matter the numbers of group members, so like-minded and dedicated groups should work together but thinking that how many right holders could be mobilized for the specific issues.
- Divide the role very explicitly and follow up the action plan regularly.
- Involve to right holders as much as possible who can aggressively contribute to campaign and movement.
- Implement the action plan whatever you developed.
- Document the process and results very sensitively also disseminate among contributors and stakeholders.

7. Conclusion

In Reality, as far as we know based on our information, World Social Justice Day was celebrated for the 1st time in Nepal. To celebrate this World Social Justice Day, Freedom for All Nepal (FAN), Global Alliance Against Untouchability (GAAU) and Society for Humanism (SOCH) Nepal had coordinated with all civil society organizations working in social justice. The first meeting was organized with almost 18 civil society organizations and made a network to celebrate the day.
